# RULES AND REGULATION

## **VENUE, DATE AND TIME**

HRIT University, 1<sup>st</sup> National Moot Court Competition will be conducted in virtual mode by the Faculty of Legal Studies, HRIT University, Delhi NCR Campus, from 20th to 21st February 2026

## **LANGUAGE**

The competition will be conducted in bilingual (Hindi/English).

## **ELIGIBILITY**

Open to students pursuing LLB (three or five years) in the current academic year. Each team should consist of two speakers and one researcher; however, two-member teams may be allowed at the organizer's discretion. Researchers may request prior permission in the event of the speaker's unavailability. Team identity disclosure is prohibited, with penalties for violations. Teams will be assigned codes for anonymity, and names must not appear in submissions.

## **REGISTRATION**


Registration opens on 25/09/2025 and closes on 31/01/2026. The registration fee is ₹ 2000/- per team. Payment must be made before completing the registration form, including a screenshot of the transaction. The fee is non-refundable.

- Teams must submit Memorials for both sides (Petitioner and Respondent) in MS Word format via email [mootsociety@hrituniversity.edu.in](mailto:mootsociety@hrituniversity.edu.in) by 12/02/2026.
- File names must include the team code and side
  - (01 P), e.g. (01) for TEAM and (P) for Petitioner)
  - (01 R), e.g. (01) for TEAM and (R) for Respondent)



The memorial submission shall consist of the following mandatory heads:

- I. Cover Page
- II. Table of Contents
- III. List of Abbreviations (In Alphabetical Order)
- IV. Index of Authorities (With Page Number of Authorities Cited)
- V. Statement of Jurisdiction
- VI. Statement of Facts (Not Exceeding 2 Pages)
- VII. Statement of Issues
- VIII. Summary of Arguments
- IX. Arguments Advanced
- X. The Prayer

### **THE COVER PAGE INCLUDED**

- I. Team Code in the Upper Right-hand Corner.
  - II. The Name and Place of the Jurisdiction
  - III. The relevant provision under which case is filed
  - IV. Name of parties and status
  - V. The side for which written submission has been prepared
  - VI. Memorial filed on behalf of.....
  - VII. It is further clarified that the organizing committee reserves the right to refuse
- ◆ The Memorial as a whole shall not exceed 50 pages including the cover page. Noncompliance shall Result in a penalty of 1 point for every additional page.
  - ◆ The memorials shall be typed on A4 size paper having one-inch margin on all the sides.



- ◆ The font shall be Times New Roman, Font Size being 12 and line spacing shall be 1.5. For Footnotes, Font Size shall be 10 with line spacing of 1.
- ◆ Page numbering shall be at bottom of each page.
- ◆ Participants must follow the bluebook 20th edition style of citation.
- ◆ The cover page of the memorial for the petitioner/applicant must be blue, while for the Defendant/respondent's memorial, it must be red. The colour of the cover page shall compulsorily be red and blue (as the case may be) and no other variant of the colour shall be used.
- ◆ Once the written submissions have been submitted, no revisions, supplements, or additions will be allowed.
- ◆ Submission of 3 hard copies of each petitioner and respondent shall physically reach the university by 08/02/ 2026.
- ◆ Submission of the memorials after the specified Last Date shall result in a deduction of three (3) Marks each day. Failure to submission of memorial would result in disqualification of the team from the competition.
- ◆ Each team shall be provided with the copy of the written submission of the opponent team at least 20 minutes prior to the respective rounds.
- ◆ The organizers of this competition shall be permitted to use all the memorials for any reporting or compilation without further permission. The submission would be deemed to be permitted. Moreover,
- ◆ Every memorial will be marked on a total of 100 marks.





## **CHANGES IN SOFT COPY**

Revised or shortened versions of pleadings post-submission will lead to disqualification.

## **CONDONATION OF DELAY**

Delays in memorial submissions will not be excused, except under extraordinary circumstances, at the organizers' discretion.

Speakers would be adjudged under the following categories during their Oral Presentation.

## PENALTIES

## RESEARCHERS TEST

- ◆ The Researcher's Test will be conducted on Day 1 of the Competition, lasting 30 minutes.
- ◆ The test comprises 20 multiple-choice questions (MCQs), each carrying one mark, with a penalty of 0.25 marks for incorrect answers.
- ◆ The score from **this test will not be added to the team's overall score**. However, the "Best Researcher" award will be given to the participant with the highest score. In case of a tie, the award will go to the researcher with fewer incorrect answers.

- The moot proposition is fictitious and purely for competition purposes. Any resemblance to actual persons, incidents, or events is coincidental.

## **COMPETITION STRUCTURE**

The competition includes Preliminary, Quarter-Final, Semi-Final, and Final Rounds. During oral rounds, the speaking order will be:

- Petitioner Speaker 1
- Petitioner Speaker 2
- Respondent Speaker 1
- Respondent Speaker 2
- Rebuttal

## **TIME ALLOCATION**

- Preliminary Rounds: 15 minutes per side, plus up to 5 minutes for rebuttal.
- Quarter-Final Rounds: 20 minutes per side, plus up to 5 minutes for rebuttal.
- Semi-Final Rounds: 25 minutes per side, plus up to 5 minutes for rebuttal.
- Final Round: 30 minutes per side, plus up to 10 minutes for rebuttal or sur-rebuttal.



## **EXCHANGE OF MEMORIAL**

- Memorials will be exchanged based on the Draw of Lots before each round.
- The determined side and team clash will be final, and requests for changes will not be entertained.

## **PRELIMINARY ROUND**

- The top eight teams qualify for the Quarter-Finals based on aggregate Preliminary Round scores. Memorial marks will serve as a tiebreaker.

## **QUARTER-FINAL ROUND**

- The top four teams advance to the Semi-Finals.

## **SEMI-FINAL ROUND**

- The top two teams advance to the Finals.

## **FINAL ROUND**

- The winner will be determined based on the Final Round scores.

## **MISCELLANEOUS**

Strict adherence to competition rules is mandatory. Deviations may result in penalties or disqualification at the discretion of the Organising Committee. The Organising Committee reserves the right to amend the rules with prior communication to participants.



# MOOT PROPOSITION

The Republic of Aryavrat is a democratic nation governed by a written Constitution and follows a common law legal system similar to that of Bharat (India). Aryavrat recognises fundamental rights under its Constitution, including the right to life and personal liberty, freedom of speech and expression, and equality before the law. It also follows the legal framework outlined in the Aryavrat Nyaya Sanhita, Aryavrat Sakshya Adhiniyam (ASA), and Aryavrat Family Laws, which are identical in content to those of India.

In the cosmopolitan city of Rajdeep, Sana Fatima (25), a practicing journalist and a Hindu by birth who later converted to Islam of her own will in 2022, entered into a live-in relationship with Aarav Khurana (28), a Hindu man working as a corporate lawyer. The two lived together for over 1.5 years in the city. Although their families disapproved of the relationship due to religious and social differences, the couple shared a rented apartment, held joint financial accounts, and even introduced each other as partners on various occasions.

On 11th January 2025, Aarav allegedly left the house suddenly and cut off all contact with Sana. Upon inquiring, Sana came to know through mutual friends that Aarav was getting engaged to a woman of his family's choice. Distressed, Sana approached the police station at Rajdeep and filed a complaint alleging emotional and psychological abandonment and fraud, claiming that Aarav had "promised marriage" and exploited her under the guise of a long-term live-in relationship.





Simultaneously, Sana also filed a petition before the Hon'ble High Court of Rajdweep under Article 226 of the Constitution seeking protection for her life and liberty, stating that her family and Aarav's family are threatening her for publicly speaking about their relationship and conversion. She also sought directions to declare her live-in relationship as valid and to provide legal recognition to the rights arising out of such relationship, including maintenance and protection under the Protection of Women from Domestic Violence Act, 2005 (as applicable in Aryavrat).

Aarav, in his response, denied any promise of marriage and contended that the relationship was consensual and did not involve any legal or social commitment. He also argued that the relationship was not equivalent to a marriage and therefore, Sana is not entitled to claim rights available to a legally wedded spouse.

The State opposed the petition, stating that live-in relationships are not recognized formally in Aryavrat Law unless certain conditions akin to a presumed marriage are satisfied.

The High Court admitted the petition and referred the matter to the Hon'ble Supreme Court of Aryavrat, given the significant questions of law and public importance involved in the case.

### **Issues for Consideration:**

1. Whether a live-in relationship of over 1.5 years, without formal marriage, entitles the woman to maintenance or protection under the Protection of Women from Domestic Violence Act, 2005?
2. Whether a promise of marriage in a live-in relationship, if proven, constitutes fraud or exploitation under civil or criminal law?



3. Whether the right to life and liberty under Article 21 of the Constitution of Aryavrat includes the right to choose a partner and cohabit without marriage?
4. Whether interfaith live-in relationships are protected under constitutional rights in light of personal law and social norms?
5. Whether live-in relationships should be granted legal recognition and what parameters, if any, should govern them?

**Instructions to Teams:**

- The Moot is limited to the issues and facts stated above. No new facts shall be introduced.
- All laws, statutes, and precedents applicable in Bharat shall be applicable in the Republic of Aryavrat.
- Each team shall argue from both the Petitioner and Respondent sides in different rounds.
- No assumption of fact is allowed unless it logically arises from the given facts.
