

### Points raised: •


- Requirement for dedicated classrooms, **library**, **Moot Court Hall**, and **Legal Aid Clinic**.

- Separate **administrative support** for B.A.LL.B. coordination.


### Resolution:


The proposal for a separate B.A.LL.B. building was unanimously approved and recommended to the university administration for further action.
